Dokumen ini berisikan:

Pasal 34

(1) Dalam melaksanakan kegiatan caturdharma perguruan tinggi, UST dapat menjalin kerja sama akademik dan non akademik dengan perguruan tinggi lain, instansi pemerintah, dunia usaha/industri, perorangan, dan/atau lembaga lain baik di dalam maupun di luar negeri.

(2) Kerja sama akademik

(3) Kerja sama non akademik

(4) Kerja sama dengan perguruan tinggi lain/instansi luar negeri dapat dilaksanakan apabila memenuhi ketentuan perundang-undangan yang berlaku.

(5) Ketentuan lebih lanjut mengenai kerja sama diatur dalam Standar SPMI Kerja sama.

Pasal 35

Kerja sama **dilakukan secara melembaga** dan dapat diselenggarakan oleh Universitas, Fakultas/Direktorat, Program Studi, Lembaga, Unit Pelaksana Teknis (UPT), dan unit kerja lain di UST dan menjadi tanggung jawab Rektor.

EVALUASI

Evaluasi (E) Standar SPMI merupakan kegiatan untuk mengevaluasi terhadap proses, keluaran dan hasil dari pelaksanaan Standar SPMI. Evaluasi atas pelaksanaan Standar SPMI dapat berbentuk Audit Mutu Internal (AMI) dan Monev (pengukuran tingkat pemahaman/kepuasan). AMI dimaksudkan untuk mengetahui kesesuaian isi standar dengan pelaksanaannya. Satuan Penjaminan Mutu Fakultas (SPMF) mengkoordinasi pelaksanaan AMI di setiap program studi. AMI dilakukan oleh **Auditor Internal** di UST. Monev dilaksanakan untuk mengetahui tingkat kepuasan dan/atau tingkat pemahaman.

Evaluasi dilaksanakan dengan **AMI** yaitu **Proses pengujian yang sistematis, mandiri, dan terdokumentasi untuk memastikan pelaksanaan kegiatan dan ketercapaiannya sesuai prosedur dan hasilnya telah sesuai dengan standar**. Sedangkan **monev** dimaksudkan **untuk mengetahui tingkat pemahaman sivitas akademika terhadap visi keilmuan dan tujuan program studi**.

PENGENDALIAN (P)

Pengendalian standar SPMI merupakan tindak lanjut atas hasil yang diperoleh dari kegiatan evaluasi. Jika hasil evaluasi menunjukkan bahwa pelaksanaan isi standar telah sesuai dengan apa yang direncanakan sehingga dipastikan isi standar akan terpenuhi, langkah pengendalian hanya berupa agar hal positif tersebut tetap dapat berjalan sebagaimana mestinya. Apabila ditemukan kekeliruan, ketidaktepatan, kekurangan atau kelemahan yang dapat menyebabkan kegagalan pencapaian isi standar, maka dilakukan pengendalian. Langkah pengendalian berupa tindakan korektif atau perbaikan memastikan pemenuhan kriteria di dalam standar.

RTM merupakan suatu rapat dengan periode waktu tertentu yang bertujuan untuk membahas tindak lanjut hasil temuan (evaluasi yang telah dilakukan). RTM dipimpin langsung oleh pimpinan terkait yang dihadiri seluruh jajaran manajemen terkait. **RTM** dilaksanakan ditingkat Program Studi selanjutnya hasilnya diteruskan ke SPMF untuk bahan rapat tinjauan manajemen di tingkat fakultas
